**RE-ADVERTISEMENT NOTICE**

**Subject: -** Re-Notification regarding Engagement/Hiring of Helpers/AAYAs under support at Pre-Primary (ECCE) for the year 2026 and submission of Application form thereof.

**Reference:-** Directorate of Samagra Shiksha's J&K (UT) letter No:- Edu/PD/SmS/ECCE/AAYA/4517-41/2024-25 Dated:-23-04.2024, Communication No. Edu/ PD/SmS/Grievances/AAYA/11303-04/24-25 dated. 18.11.2024, Chief Education Officer Kishtwar's No:- CEO/K/2024/5444-5463 Dated: -19-06-2024, No. CEO/K/2026/39907-10 Dated. 25.03.2026 and this office Advertisement Notice No.ZEO/I/2026/15000 dated. 26-02-2026.

Whereas, this office had initiated the process for hiring of AAYAs in 59 schools vide Advertisement Notice No. ZEO/I/2024/1163-1283 dated 27-06-2024.

Whereas, subsequent directions were received from higher authorities to withhold the process for engagement of 59 AAYAs/Helpers and to curtail them to 24 posts in order to meet the requirement of funds vide no: - CEO/K/2024/9374-80 dated 10-08-2024.

Whereas, direction has been issued that 24 AAYAs/Helpers shall be engaged in those schools where higher enrolment exists, strictly as per norms and availability of sanctioned posts vide No. CEO/K/2026/35859-61 Dated 17-02-2026.

Whereas, Advertisement was issued by this office wherein application were invited for the engagement/Hiring of Helpers/AAYAs under support at Pre-Primary (ECCE) for the year 2026 by this office vide No. ZEO/I/2026/15000 dated. 26.02.2026.

Whereas, various representations/Grievances were received regarding issuance of Advertisement at Habitation Level instead of Revenue Village Level having more than 01 habitation/ different Schools in the same Revenue Village.

Whereas, taking in cognizance of the matter, Chief Education Officer Kishtwar vide No. CEO/K/2026/39907-10 dated. 25.03.2026 has issued instructions to this office to review the issue regarding advertisement of posts of AYYA/Helper at Habitation Level instead of Revenue Village level in case of having more than one school in the same Revenue Village strictly in consonance with the prescribed guideline/norms laid down by higher authorities from time to time.

Whereas, clarification in this regards was also issued by Directorate of Samagra Shiksha J&K vide No. Edu/PD/SmS/Grievance/AAYA/11104-05/2024-25 dated. 08.11.2024 wherein instructions have been issued with regard to advertisement of the posts for engagement of AAYA in different Schools of same revenue Village, and it has been directed **that every School for which post of AYYA has been approved may issue separate notification and receive applications from concerned habitation for the post and may constitute specific panel for selection in respective schools** so as to avoid conflict in selection process.



Whereas, the matter was reviewed by the undersigned with reference to Chirag Notification and subsequent guidelines issued from time to time by higher authorities especially the instructions laid down in communication dated. 08.11.2024 & 08.11.2024 and 25.03.2026 and it have been established the Advertisement issued by this office dated. 26.02.2026 was issued on Village level inadvertently instead of Habitation Level in case of those Schools having same Revenue Village and continuation of the same shall results into utter chaos, unnecessary litigations and are also in contradiction to the guidelines issued by Directorate of Samagra Shiksha J&K dated. 08.11.2024.

Whereas, consequently, the Advertisement issued by this office dated. 26.02.2026 stands withdrawn ab-initio by virtue of order No. ZEO/1/2026/15-19 Dated. 04.06.2026.

Whereas, the said posts is hereby Re-advertised on Village level/habitation level (In case of having different Schools in same Revenue Village) in terms of clarification dated. 08.11.2024 and accordingly applications are re-invited from deserving eligible female candidates for Engagement/Hiring of Helpers/AAYAs under ECCE for the year 2026 in various schools as listed below of Education Zone Indermal.

**Eligibility Criteria:-**

- i) Only Female candidate may be deployed.
- ii) The helper deployed must be a domicile of the concerned habitation where approved School is located.
- iii) Candidate must be belonging to BPL (Below Poverty Line) category.
- iv) The candidate must be Physically/Mentally fit to carry out her job.
- v) The candidate must belong to the habitation/Village concerned as the case may be.

**Qualification/Preferences: -**

- i) Educational Qualification:- Minimum 8<sup>th</sup> passed, the candidate with lesser qualification shall be considered only in if there is no eligible candidate available in the habitation.
- ii) Preference shall be given to candidates from BPL category in the below mentioned order of priority: -
  - a) Widow
  - b) Divorced
  - c) Orphan

The orphan candidate must be unmarried women between the age of 18-45 years whose biological parents are dead and preference in this regard shall be given in the below mentioned order of priority.

  - i. Double Orphan (Women whose both biological parents are dead shall be given first preference.
  - ii. Paternal Orphan (Women whose biological father is dead) shall be given second preference.
  - iii. Maternal Orphan (Women whose biological mother is dead) shall be given third preference.
- iii) The age of the candidate must be between 18-45 years as on 1st of January of the deployment year i.e. 2026.
- iv) Habitation Certificate from the concerned Rural Development Department.
- v) Honorarium of Rs. 5000/- per month which may vary as per the approval of the subsequent year in PAB of Samagra Shiksha.
- vi) In case, if no candidate falls under the Orphan, Widow, Divorcee, the female candidate belonging to BPL Category and Older in age shall be considered.
- vii) In case of further tie up of the selection of candidate for Helper/AAYA, the preference shall be given to the candidate on the basis of higher merit obtained by the candidate in the minimum qualification having same date of birth.
- viii) In case of any misconduct, misbehavior and poor performance while discharging duty by Helper/AAYA, the concerned HOIs/ZEO shall have the right to terminate the services of Helper/AAYA in consultation with the Habitation/Village.
- ix) In case of having more than one School in the same Revenue Village, the selections shall be made on habitation level on the basis of specific panel for selection in respective Schools to avoid conflict in selection process.

**x) Documents required: -**

- a) Qualification certificates along with the Marks Card.
- b) Domicile Certificate.
- c) Date of Birth Proof.
- d) Health Certificate.
- e) BPL Ration Card.
- f) Death Certificate in case of widow/orphan.
- g) Divorce certificate in case of divorced candidate.
- h) Habitation Certificate from Rural Development Department.
- xi) Last date of submission/receipt of application form is **13.04.2026** up to **4.00 pm**.
